1. When will this be available?

The integration of Closing Protection Letters (CPLs), Back Title (where available), and Policy Jackets is currently available to Closers' Choice.

2. How do I start using this integration?

When available, you may begin using this integration provided you have an active AgentNet® account and have registered for a Closers' Choice account.

3. Do I need to install anything and how?

You should contact someone in Closers' Choice Customer Service about any required steps for your current version.

Previously ordered services in AgentNet will not populate to your Closers' Choice file.
