







RamQuest and Clear2Go - Order Searches and Commitments

Learn about Clear2Go eligibility and how to place a Clear2Go Search and Commitment order in RamQuest using the Closing Market and AgentNet Integration.

Eligibility

In addition to the other requirements set forth in the agency agreement and in the Agency Guidelines, the following conditions must be met before a transaction will be eligible for a Clear2Go Report and the information contained therein to be used to produce a Title Product*.

- **A.** Orders for residential refinance and cash-out (equity) transactions (no manufactured homes, leasehold, native American land, etc.);
- **B.** Intended Title Policy to be issued must be one of the following:
 - a. ALTA Short Form Residential Loan Policy or ALTA Short Form Expanded Coverage Residential Loan Policy,
 - **b.** ALTA Residential Limited Coverage Junior Loan Policy; or
 - c. ALTA Loan Policy, that contain generic exceptions for CC&Rs/easements
- C. Loan amounts cannot exceed \$2,000,000;
- **D.** Cash-out amounts cannot exceed \$500,000;
- E. Owners must be individuals, trusts or general partnership;
- F. Geographic Eligibility as outlined in the Agency Guidelines

Request a Search Order

Beginning from an open RamQuest file:

- Click
- 2. In the Closing Market Services window, select First American AgentNet
- 3. Click Submit



- 4. In the Login screen, enter your AgentNet login credentials
- 5. Click Login

NOTE: If a file has been created in AgentNet, proceed to Step 9.

- 6. In the Closing Market Services window, enter file details
- 7 Click Create File



Clear2Go Product Options (where available)

Please contact your Sales Representative or Technical Consultant to enable these options.

- 1. Clear2Go + Tax: Clear2Go +Tax is a feature that enables you to receive your normal Clear2Go package first, followed by a Tax Search document. Though each product can be ordered separately, the advantage of Clear2Go + Tax is making one system request and receiving two products. If this feature is enabled, you'll receive an email when the Tax document is ready.
- 2. Clear2Go Cascade: Clear2Go Cascade is an automatic feature in applicable states and counties that quickly requests an AgentNet Search Product (ASP) when your Clear2Go result does not meet search requirement (i.e., Complexity indicator results other than Streamline).

Clear2Go Cascade Process Flow

If Clear2Go Cascade functionality is enabled:

- 1. You'll receive an email confirming you placed an order
- 2. When the Clear2Go result is available you'll receive an email when your Clear2Go order cascades to an ASP NOTE: For initial Clear2Go product requests, you'll receive limited Clear2Go XML data and a Summary Report Document as the first delivery. Follow the instructions in the 'Receive Clear2Go Search Job Aid'.
- **3.** You'll receive an email when your ASP is complete, including links to associated documents **NOTE:** Follow instructions provided in 'Receive Search and Commitments Job Aid'.
