






Order and Void an eJacket in SnapClose

Required Information

Transaction Type, Property Type, NAIC Type, Liability Amounts











Order an eJacket

- 6. Select Order Policy Jacket







Repeat the process for additional jackets as applicable.




1. Select Void Jacket
