




SDN Search - Request in TitleFusion

Learn how to request a SDN search from your TitleFusion file using the AgentNet® integration after you add parties to your file.

Access the Integration

- On the **Application** screen, click the **Underwriter** hyperlink



Select Firm, Office, and Underwriter


- If applicable, select the **Firm** in the drop-down list
- If applicable, select the **Office** in the drop-down list
- If applicable, select the **Underwriter** in the drop-down list



NOTE: If you have previously submitted a request for a product or service for the file, these options will be grayed out.

Select Parties and Submit Search

- Under Underwriter Integration, select **SDN Search**



NOTE: The parties auto-populate from your file into the fields in the **Search Parties** area of the screen. All parties are selected by default.

- Click a checkbox to de-select a party from the search if needed
- Click **Add Additional Party** if needed
 - Enter the party's full name
