

Job Aid: Pay StreamLine ASP Invoices with Credit Card in AgentNet


This document will outline the process of paying StreamLine ASP Invoices in AgentNet.

NOTE: Payments must be processed monthly, as Agent Credit Cards are not stored.

Pay StreamLine ASP Invoice

From the **Pay** Tab within My Remittance Reporting:

- 1. Select StreamLine Fee
- Click ePay



NOTE: A **Confirmation box** will appear requesting the user to confirm the invoice amount due.

- 3. Select Credit Card Radio Button
- 4. Click Yes



NOTE: The **PayConnexion** portal will open.

- 5. Select Payment Method
- 6. Enter Card Number
- 7. Enter Card Account Information
- 8. Click Continue




NOTE: A Confirmation Page will open after Credit Card information has been submitted.
