

2. Select Title Insurance Remittance Report or Title Insurance Remittance Report NY




Complete the applicable report parameters:


3. Click Save Remittances to save a copy of the remittance




NOTE: Checking the option to **Save Report to Documents** will save a copy of the remittance within each file's document repository.
